## **DEPARTMENT DIRECTIVE 17-003** (DC OLIVER-6/20/17) **75TH ANNIVERSARY PINS-TEMPORARY MODIFICATION OF SOP 6-23**

In recognition of Central Kitsap Fire & Rescue reaching a milestone of dedicated service to the community, we will be issuing to all personnel 75<sup>th</sup> Anniversary lapel pins. <u>Wearing this pin is optional</u>, however, if worn; the pins will be proudly displayed within the following parameters for the remainder of the 2017 calendar year.

#### **Uniformed Personnel:**

- The pin will be worn on Class B uniforms and in lieu of the union pin if applicable.
- The pin will be located on medial side of right front pocket flap (see; I was a Paramedic).

#### **Non-Uniformed Personnel:**

- The pin will also be worn on the medial side of the right front pocket when applicable.
- If you are wearing clothing that does not have pocket flaps you will wear the pin on upper right quadrant of your ensemble.

## NON-EMERGENT COMPLAINTS: 360-307-5811

Due to the heavy workload associated with the 4<sup>th</sup> of July holiday, law enforcement agencies must triage their workload and their ability to respond based on the level of threat to safety of citizens and property. For this reason, all Kitsap County law enforcement agencies will not be responding to firework complaints that pose no imminent threat to life or property. This allows personnel resources to be utilized for emergency responses. Citizens may call their local law enforcement office during business hours for further information on responses to firework complaints in their area.

To avoid overwhelming the 911 system over this year's Fourth of July holiday, KITSAP 911 is encouraging the public to call **360-307-5811** with non-emergent complaints. From Friday June 30, 2017 at 1 PM through Wednesday July 5, 2017 at 7 AM, that number will ring into the 911 center but calls will be handled as a lower priority than 911 emergency calls.

## **TECH RESCUE DRILL AT RETSIL VETERANS HOME**

On June 15, members of the Region 2 Technical Rescue Team, (made up of members from South Kitsap Fire & Rescue, Bremerton Fire, Navy Region Northwest Fire, Bainbridge Island Fire, North Kitsap Fire & Rescue, Poulsbo Fire and Central Kitsap Fire & Rescue) held a drill at one of the buildings set for demolition at Retsil Veterans Home in Port Orchard Washington.

The drill simulated workers caught in a collapse in the building and the only access was through windows. Shoring is used to support windows, ceilings and walls to prevent further collapse while team members attempt to access the trapped workers. Despite the constant drizzle and rain, the drill was a success.

Retsil Veterans Home has made this building available on several occasions in the past 12-18 months for multiagency drills for fire training as well as this latest drill for technical rescue.

Last Friday on Tracyton Beach Road, CKFR units responded to a vehicle over an embankment with one person entrapped. E41, E45, E50, M41, R51 and BN51 arrived to find one vehicle approximately 15' below the roadway in dense brush with a patient still in the vehicle. Crews accessed the patient, determined that they had minor injuries, and placed them in a Stokes basket and used a rope rescue system to haul them back up to the roadway. The patient was then treated and transported by M41 crews.

## A new Golden Rule for leadership

Leaders and managers seeking to engage, motivate and retain employees should consider adopting a slightly revised version of the Golden Rule.

"Manage others as you want to be managed" is the lesson that can be drawn from a recent study of the relationship between varying degrees of work autonomy and levels of employee satisfaction and perceived well-being. The findings indicate that a traditional top-down, command-and-control management style — still widely in use — is counterproductive in many of today's businesses.

Researchers at the University of Birmingham Business School <u>compared</u> data collected in two separate years from some 20,000 employees in the United Kingdom in order to examine employees' reported changes in well-being relative to levels of work autonomy.

Their analysis found that those in management reported the highest level of autonomy, with 90 percent saying they experienced "some" or "a lot" of autonomy, along with high levels of perceived well-being and job satisfaction. Professionals reported having lower levels of autonomy than managers. Around 40 to 50 percent of mid-level employees reported they had little autonomy, and half of those in lower skilled jobs reported no autonomy in how they carried out their work.

The researchers found corresponding declines in job satisfaction and perceived well-being as levels of work autonomy decreased.

In particular, the study found, employees want greater control over their work tasks and schedule. The study also found that the types of autonomy employees prized varied by position and gender.
