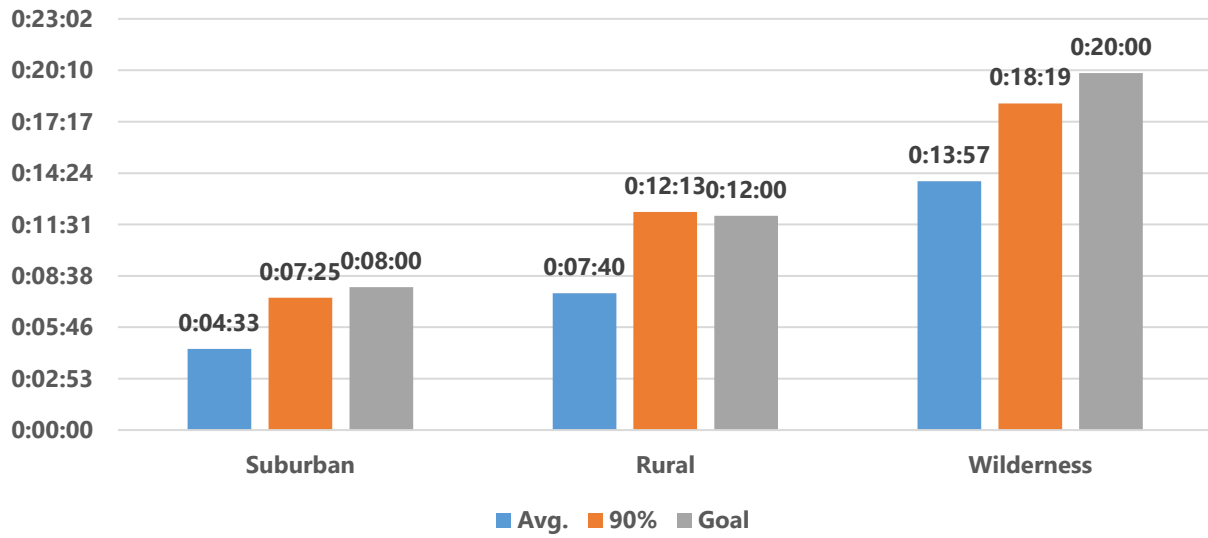

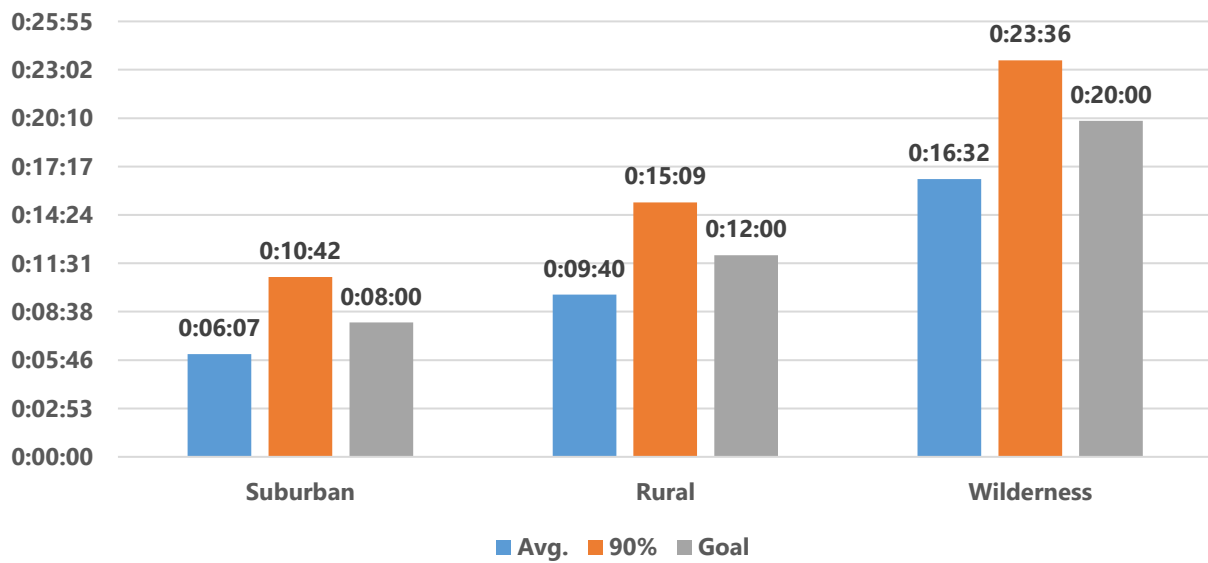

Predictable Consequences

Currently, CKFR meets the average response times in all geopolitical zones (suburban, rural and wilderness), but, like most other Fire Districts, CKFR falls short of meeting national 90% fractile goals. The main contributing factor is dramatic swings in the fractile due to a relatively low total number of calls. Only the largest departments meet this fractile because of their larger call volumes. Another contributing factor is the continued growth and expansion of the Fire District's population and infrastructure (number of citizens, buildings, developments, etc.).

With the Central Kitsap community developing at an accelerated rate and more citizens moving into the area, the Fire District will need to continually evaluate its operational effectiveness and plan for the future. Nearly all of our front-line apparatus will have been replaced in 2019 and 2020. Updating and building new facilities and increasing staffing are the two main components needed to keep up with the dramatic growth our community is experiencing.

Plan of Action

A facilities bond is planned for 2020. This bond will update and/ or replace nine of the District's fire stations. If passed, it will fund new fire stations in Illahee (Station 45), in Silverdale (Station 51), and three stations in Seabeck at Lake Symington (Station 57), at Anderson Hill Rd/Olympic View Rd (Station 52) and one near the Seabeck Marina (Station 53). Stations 41 in Meadowdale, 64 in Chico and 56 in Seabeck will all benefit from remodels in the plan.

Eleven new firefighters are slated to be brought on in 2020. These new employees will give the District the ability to increase minimum staffing by staffing a BLS unit full time at Station 41. This Aid Car will decrease the burden on Paramedic units at Station 41 and Station 51.
